## New Stewardship Plan Shapefile Requirements

ArcGIS shapefiles containing the mandatory associated files (.shp, .shx, .dbf, .prj, .sbx, .sbn, .xml). The shapefile(s) is/are to also contain the mandatory projection of:

- Universal Traverse Mercator (UTM);
- Zone 16 or 17;
- Datum NAD 1983;
- Units in meters.

Also the mandatory .dbf file associated with each individual shapefile is to have the following attribute information in separate columns i.e. fields:

- District (Numeric)
- County (Capitalize Proper Name)
- Calendar Month (Capitalize Proper Name)
- Calendar Year (Full Year-Text)
- Forester Last Name (Capitalize Proper Name)
- Forester First Name (Capitalize Proper Name)
- Landowner Last Name (Capitalize Proper Name)
- Landowner First Name (Capitalize Proper Name)
- Woodland Acres (Numeric)
- Primary Objective (Capitalize Proper Name)
- Secondary Objective (Capitalize Proper Name)
